SUBJECT: Free and Open Public GIS Data

EXECUTIVE SUMMARY:

Ramsey County, along with most other counties in Minnesota, has implemented a fee structure for the acquisition of its Geographic Information System ("GIS") data by external entities. This fee schedule was established in the 1989 when the GIS was relatively new to the County as a means of capturing some of the costs of developing and maintaining this new asset. However, since then changes in technology, legal landscape, and views on the value of public data have converged with a decline in revenues and recognition of other costs associated with collecting fees for data. As a result, there is a trend across the country towards granting free and open access to public GIS data. ACTION REQUESTED

- 1. Authorize implementation of public access to public GIS data in a commonly recognized and easily produced form without fees or user licenses, subject to a data disclaimer.
- 2. Authorize County Departments to continue to charge fees for fulfilling customized requests such as development of specific maps, applications, analysis, or customized versions of the data as governed by applicable language in the Data Practices Act.
- 3. Direct the Department of Information Services to coordinate with other counties, cities, and governmental agencies to simplify and consolidate access to public GIS data.
- 4. Authorize the County Manager to make budget adjustments and Fee Report changes as needed to reflect the elimination of fees for GIS data consistent with above requested actions.

EXECUTIVE SUMMARY, Continued

In October 2013, the MetroGIS Policy Board, the governing body for the MetroGIS collaborative of government, non-private, private and academic partners, and of which Commissioner Reinhardt is a member as appointed by the Ramsey County Board of Commissioners, passed a resolution to support the concept of Free and Open Public GIS Data and encourage local governments within the Metro Area to adopt policies and practices consistent with this approach to data access. In keeping with this resolution, the Chair of the MetroGIS Policy Board sent a letter to the Ramsey County Board Chair on November 20, 2013 (See Attachment 2).

Recent revenue generated by charges for GIS data has been relatively insignificant; estimated revenue for 2014 from this source is \$3,000, all of which is collected by Public Works. Public Works is confident this loss of revenue can be absorbed within its current budget.

The Ramsey County GIS Manager contributed to the MetroGIS report and supports its findings. Management staff in both Public Works and Property Records and Revenue, the two departments with the most GIS public data, also support the transition to a free and open public GIS data practice. While there may be several methods eventually implemented for data access, the first and most simple would be accomplished by making a downloadable GIS file accessible via a link on the Ramsey County public web site.

This Request for Board Action is intended to establish Ramsey County's support for free and open access to public GIS data through the elimination of fees, and the removal of requirements for licensing agreements on the users of public GIS data. As a result of this action, the County is encouraging public access and use of this information, thereby maximizing the value of a publicly funded asset.

DRAFT RESOLUTION

WHEREAS, Ramsey County creates, maintains and possesses valuable geographic information systems (GIS) data to support its various business purposes; and

WHEREAS, Ramsey County recognizes that this GIS data is also a public resource and there are significant benefits to making this data freely and openly available; and

WHEREAS, In October 2013, the MetroGIS Policy Board, the governing body for the MetroGIS collaborative of government, non-private, private and academic partners, and of which Commissioner Reinhardt is a member as appointed by the Ramsey County Board of Commissioners, passed a resolution to support the concept of Free and Open Public GIS Data and encourage local governments within the Metro Area to adopt policies and practices consistent with this approach to data access; and

WHEREAS, The emergence and continued refinement of new information technology has dramatically changed the way citizens search for and expect to find, consume and utilize information, and such technology can aggregate ever larger quantities of data and allow government to provide information to the public with increasing efficiency; and

WHEREAS, Ramsey County can leverage this technology to meet the public demand for information, enhance public access to government data and make government processes transparent in order to promote public trust; and

WHEREAS, Ensuring the quality, consistency and availability of such data is a core function of government and is essential to maintaining the data's value and utility; Now, Therefore, Be It

RESOLVED, The Ramsey County Board of Commissioners hereby authorizes implementation of public access to public GIS data in a commonly recognized and easily produced form without fees or user licenses, subject to a data disclaimer; and Be It Further

RESOLVED, The Ramsey County Board of Commissioners authorizes County Departments to continue to charge fees for fulfilling customized requests such as development of specific maps, applications, analysis, or customized versions of the data as governed by applicable language in the Date Practices Act; and Be It Further

RESOLVED, The Ramsey County Board of Commissioners directs the Department of Information Services to coordinate with other counties, cities, and governmental agencies to simplify and consolidate access to public GIS data; and Be It Further

RESOLVED, The Ramsey County Board of Commissioners authorizes the County Manager to make budget adjustments and Fee Report changes as needed to reflect the elimination of fees for GIS data consistent with above requested actions.
